## Montana Municipal Interlocal Authority (MMIA)

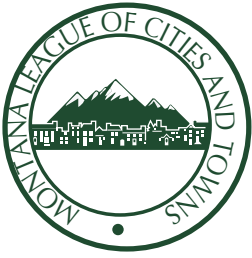
